BOOKS

This talk is being given on June first, 2020, at which time at least in new Jersey our libraries are still close, they should be opening soon, but luckily many of the books, that we use to research our Bergen County Ancestors can be found online, where they can be searched, copied or even downloaded as the entire book. I usually check the Family Search Digital Library familysearch.org, Sometimes books not found at FamilySearch.org, can be located at GoogleBooks.com, HathiTrust.org, OpenLibrary.org or Internet Archive https://archive.org/.

BERGEN COUNTY HISTORIES

These books contain a wealth of information, and as they were all written more than seventy five years ago, are no longer protected by copyright laws, and are all available online. They usually contain, military, political history of the county and municipalities within the county. Excellent resources for change of names and boundary lines, what churches were in the area and when. etc. The books are sometimes referred to in a derogatory manner as "Mug Books." That is because in order to raise money for the publications of the books, subscriptions were sold in advance and subscribers, depending on how much they paid, had their self submitted biographies and family histories, often with their picture (mug shots) included in the books. No effort was made to verify the informations submitted and they often contained errors.
