### New Jersey's 22nd Regiment in the Civil War

An article in the 9 Oct 1996 issue of *Pascack Valley Community* Life focused on chapter 16 of the book, <u>New Jersey and the</u> <u>Rebellion: A History of the Services of the Troops and People of</u> <u>New Jersey in Aid of the Union Cause</u>, by John Y. Foster. The book was published in Newark in 1868.

Chapter 16 tells the story of the 22nd Regiment, composed almost exclusively of volunteers from Bergen County. The 22nd Regiment was mustered into service at Trenton on 22 September 1862 and was soon encamped at Capitol Hill in Washington, D.C. By December, the unit was on its way to Fredericksburg, VA, during which the men sufferered a march that taxed their endurance to the utmost. Then, upon their arrival, they experienced a cold and pitiless two-day storm. Many familiar ancestral Bergen County names appeared on the 22nd's rolls, including Demarest, Blauvelt, Westervelt, and Bogert, to name just a few.

# July 11 & 12

The third joint conference of the New York Genealogical and Biographical Society (NYG&BS) and the New England Historic Genealogical Society (NEHGS) will be held July 11 and 12 1997 at the Westchester Marriott Hotel in Tarrytown, NY.

The conference will feature two days of lectures and programs on New York and New England genealogy by well-known genealogists, and will include a banquet and two luncheons with speakers. The last Tarrytown conference, in 1995, was attended by almost 450 people and received rave reviews.

# New England Computer Genealogist is now The Computer Genealogist

The publication formerly known as *The New England Computer Genealogist* has been renamed *The Computer Genealogist* and will be published bi-monthly. According to editor Stephen Kyner, the newsletter's original name reflected its association with its parent society, the New England Historic Genealogical Society, but the original name of the journal led people to assume it was a strictly regional publication. In fact, the publication has always featured articles of broad interest to all who use a computer in their genealogical work, without regard to regional specialization. The new name, *The Computer Genealogist*, will reflect and communicate more accurately the goals and content of the publication.

The new bi-monthly publication schedule will facilitate the expansion of the number of pages in each issue to a minimum of 20 and will allow more thorough, up-to-date, and in-depth articles.

GUIDELINES FOR SUBMITTING QUERIES

Only GSBC members may submit queries. We suggest that query writers scan previous printed queries for ideas for form, etc. A few general suggestions:

1. Be brief and concise, but give as much clearly written information as possible to help identify an individual (dates, places, relatives, etc.). The more info you give, the more likely someone will be able to connect with your ancestor.

2. To avoid confusion, limit queries to one or two requests about the same individual or family. If you need information about more than one individual or family, write separate, additional queries.

3. Use common, clear abbreviations. If you're not sure of an abbreviation, use the complete word or term to avoid misunderstanding.

We welcome your queries and will print them as space permits.

**FREDERICX** — Seeking the parents of Peter Bush. His will was dated 23 Jan 1801 Hempstei[sic] (Hempstead, Rockland Co., NY), and was probated 13 May 1807. Married to Margaret (Grietje) -?-. Will mentions children Derrick (Dirk) (married to Antje Vanderbeek - my

line); Catherine, wife of John Storm, (may be Horn); Margaret Sholters; Mary, wife of John Fredrick; sons, Peter, Lodewyck, Rinehart and oldest son, Conrad. Would also like to know surname of wife, Margaret (Grietje). Son Derick(Richard) died 4 July 1829 in Masonicus, Bergen, NJ or Masonicus, Rockland Co., NY and is buried Saddle River Reformed Dutch Chyd., Bergen County, NJ.

191. **RYERSE/RYERSON, SCHENCK, TERHUNE** — In <u>Pre-Revolutionary Dutch Houses...</u> [p. 64], Rosalie Fellows Bailey wrote, "On July 29, 1659 he [Adam Ryerse] married Annetje, daughter of Martin Roelofse Schenck of Flatlands; her uncle built the Schenck House on Mill Island ." However, the builder of the Mill Island house (p. 66) is given as Jan Martense Schenck. Under the usual Dutch naming conventions these two men could not have been brothers. This might be simply a typographical error, but from some source (probably Struble, Evelin Armstrong "In the Ramapos," 1966, p. 103-4, I got the reference that Annetje, dau. of Martin R. Schenck, married Jan Albertse Terhune. Can anyone sort this out for me?

BOGERT, BUSH, HOPPER, WANAMAKER, WARD — Seeking the parents of Anna Bogert, born ca. 12 May 1786 NJ (according to her tombstone and 1850 US Pop Census), and born ca 1782 according to the 1860 Mortality Census. Died 8 Jan. 1860 Hohokus Twp., Bergen Co., NJ. She married Henry R. Wanamaker, son of Richard H. Wanamaker and Catherine Bush, ca. 1802. Anna and Henry were both members of the Zion Lutheran Church in Saddle River, NJ.

Their two known children were Rachel and Richard Henry. Anna seems to be connected somehow with the families of States Bogert and wife, Anna Hopper, and his half brother, Isaac Bogert and wife, Jane Ward. The parents of Staats were Jacobus Bogert and his first wife, (poss) Rachel Storms. The parents of Isaac were Jacobus Bogert and his second wife, Elsie Earle. Both Staats and his brother Peter named their first daughters, Rachel. So did Anna Bogert Wanamaker. Jacobus Bogert mentions his children in his will, but does not mention his son, Staats. However, his brother, Peter, mentions him in his will. Any leads on this family would be greatly appreciated.

## World War II Survey

According to an item in the November-December American Genealogical Lending Library Genealogy Bulletin, the U.S. Army Military History Institute is conducting a survey to acquire source material on World War II. All veterans of the war are invited to join in this effort by writing to the U.S. Army Military History Institute, Carlisle Barracks, Carlisle, PA 17013-5008.

The Institute will send an 18-page questionnaire and the postage to return the form. The "Army Services Experiences Questionnaire" has several parts: general military service questions, overseas service, combat service, occupation and demobilization, and postwar experiences. WW II veterans are encouraged to complete the questionnaire in order to preserve their own personal memories and to add to the personal history of the conflict as a whole.

## Eastern European and Jewish Genealogy

An article by Toby Axelrod in the December 1996 issue of *Moment*, described how growing numbers of far-flung descendants of Eastern European Jews are researching their past and visiting the homelands of their ancestors. Across the country, Jewish genealogical societies have organized; to find the one nearest you, send a self-addressed stamped envelope to Association of Jewish Genealogical Societies, P.O. In-print resources include: <u>Avotaynu: The</u> <u>International Review of Jewish Genealogy</u>, one of several recent books, journals and newsletters published by Avotaynu in Bergenfield, NJ. Others include <u>Sourcebook for Jewish Genealogies and Family</u> <u>Histories, Where Once We Walked: A Guide to the</u> <u>Jewish Communities Destroyed in the Holocaust</u> and dictionaries of Jewish surnames from the Russian Empire and from the Kingdom of Poland.

The growth of genealogical interest has in turn affected travel to Eastern Europe. Today, there are travel consultants and tour businesses specifically geared to plan trips to Eastern European countries.

# Maryland Moved to

About a decade ago, officials at the National Archives in Washington, D.C. realized they were running out of space and began planning a new center. They were attracted to a College Park, MD site by the promise of a partnership with the University of Maryland, which provided the land on which to

establish what became Archives II, opened in 1994.

An article in *The Record* on 17 November 1996 recorded the completion of the three-year move of records and materials at the rate of about 9,000 boxes a day. Both Archives sites will serve as research centers. Among the records the Washington, D.C. center has retained are those of the Revolutionary and Civil Wars and of the Census Bureau. ■

◆ Answer To Query 174 (in August 1996 Archivist) concerning PULIS family, from Marjorie Smeltzer-Stevenot, 150 Johnsontown Road, Sloatsburg, NY 10974 —

1. Shortly after 1857, William J. Pulis built a large building on the corner of South Central Avenue & Main Street in Ramsey, NJ. He opened a grocery store on the ground floor, completing the second floor as a residence. A shed south of the store housed feed and grain. Under the building was a shed to accommodate horses of patrons.

James W. Pulis, his son, ran the store. James' father and two brothers, William W. and John, worked on the farm. Later James W. opened up a dry goods store on Main Street. His son William Henry took over the grocery store and was Postmaster for a number of years.

William J. Pulis was appointed Postmaster in 1861. He was followed by James W. and the office remained in the Pulis family for 20 years. A Pulis was Postmaster until the election of Woodrow Wilson in 1914. (Source: <u>The Birth and Growth of Ramsey</u>, by C. A. Smeltzer and J. Y. Dater, 1949.)

2. Andries Pulisfelt married Rachel Conklin, dau. of Joseph Conklin & Elizabeth Osborn, on 22 May 1800 at Brick Church, Kakiat. He owned a mill on Viola Road, east of the Baptist Cemetery.

3. John Pulisfelt (Pulis) was one of the earliest settlers in Bergen County. He was of German origin, from Darmstadt. (Pulis should not be confused with Powles, a Dutch family name.)

\*\*4. Jacob W. Pulis, born 19 July 1784, died 1861. Jacob was a member of the Island Church (Mahwah). His will was dated 8 April 1861, probated 30 Dec 1861. He married Maria Ackerson (Eckerson), born 17 Feb 1786, bp. Clarkstown Ref Dutch Church, dau. of Abraham Ackerson. Jacob and his wife are buried in the old Young Cemetery in Fardale (erroneously called DeBaun) now in a suburban development.

Jacob's daughter Anna (Nancy) married James Young, Esq. of Campgaw, son of Jacob Young and Anna Christie. His will was dated 30 Oct 1883, probated 27 Jan 1897. His daughter Elizabeth, born 10 June 1824, was bp. 8 August at the Zion Lutheran Church, Saddle River. She married John W. Concklin, b. about 1821. ■

## THE MABIE VIRUS

by Ethel K. Kolenut

An article, written by Sarah A Mabie, on the Mabie Family, (NYGB 52:251), started all the misconceptions about the Mabie family. Sarah A. Mabie got her "facts" from notes compiled by Edward C. Marshall, whoever he is. It began to snowball. In 1923, T.L. Van Norden published <u>The Van Norden Family</u> and the rest is history. Every Mabie descendant I know lays claim to Pierre Mabille DeNevi and his son Sargeant Casper Mabille and his wife Serrantie DeCrois Du Bois. I admit, I wanted to keep those glamorous names in my lineage. I am a Mabie descendant but my Mabie line begins with Pieter Caspersen Mabie and his wife Aechtje Jans. There is no connection between the Van Orden, Van Norden or Mabie families. Amen. — Ethel

The Van Norden Family - Three Hundred Years in America, 1623,1923 by Theodore Langdon Van Norden,

published in 1923, contains many horrendous errors, lots of speculation and nothing factual. He claims that Seigneur Pierre Mabille De Nevy was the progenitor of the Mabie, Van Orden and Van Norden families. Everything is carefully worded: "Mabille apparently served with high rank in Admiral Gaspard de Coligny's army." It "seems probable that Seigneur Pierre Mabille then left France, .....and settled in Naarden, Holland." Next we have "Caspar Mabie, born in Naarden, about 1575, probably the son of Seigneur Pierre de Mabille." Caspar "early entered the military service of Holland, and apparently was soon a sergeant ... he served upon the American coast on a Dutch cruiser which took a Spanish prize near New York. Thereafter he was always known as Sergeant Caspar."

This story grew out of a baptismal witness named "Caspar de Sergiant" in the New York Reformed Dutch Church on 6 Nov 1650. (NYDC 2:28). T.L. Van Norden also used as a reference "according to the traditions of the Putman County Mabie family."

Next in line: "Pierre Gaspard Mabille, son of Caspar Mabie and probably grandson of Seigneur Pierre Mabille de Nevy, was born in Naarden about 1600. And it seems probable that he and Pieter Casparszen Van Naarden of New Amsterdam were the same person."

I first became aware of the errors in the Van Orden/Van Norden/Mabie family lineage in 1983 when I was assistant genealogist of the Association of Blauvelt Descendants (ABD). I was foolding for information on "Maria Pieterse Van Orden," first wife of Isaac G Blauvelt, mentioned in the 1957 edition of the Blauvelt Family Genealogy (BFG #12). Searching the New York Reformed Dutch Church records (NYDC), I found no record of a Van Orden family. I did find Maria Pieterson's family, the Van Norden family.

The Van Norden Family — The progenitor of the Van Norden family in America is Pieter Wesselszen, who married Josyntje Jans on 19 May 1669 (NYDC 1:33). "Pieter Wesselszen, j.m. Van Norden in Oost Vrieslt., en Josyntje Thomas, j.d. Van Uytrecht."

Josyntje's name is variously spelled in the church records as Josyntje Thomas, Gosyntie Thomas, Francyntie Jans, and Josyntie Hoboken. Pieter Wesselszen and Josyntje had five children baptized in the NYDC: Anna, bp 26 Dec 1669; Wessel, 21 Oct 1671; MARRITIE, bp 25 Feb 1674; Johannes, bp 22 Nov 1676; and Pieter, bp 15 Jan 1679.

Marritie's mother, Josyntje Jans, married 1. Pieter Wesselszen [Van Norden ], 2. Gerrit Hendrickszen [Blauvelt] and 3. Anthony Sarley.

Gerrit Blauvelt had eight children with his first wife Saratje Van Schyven. Their seventh child ISAAC, born 24 March, bp 13 Apr 1735 (Tappan #811), married his step-sister Marritie. They were raised together as children. Isaac was 13 years old and

Marritie 5 years old when her mother married his father. The children and grandchildren of Wessel Pieterszen (Van Norden) and Josyntje Jans remained in New York.

The Van Orden Family — The Van Orden family is found in the New York Lutheran Church records and the Hackensack and Schraalenburg church records in Bergen County, New Jersey.

The earliest Van Orden I found is Jan Van Orden and his wife Lysbeth Andries Rees. Lysbeth was bp 25 Oct 1654, daughter of Andries Rees "Van delipstradt" (NYDC 2:38). Lysbeth died "15 Xbr 1735. Lisabeth Van Orden in her 82nd year. Buried in our churchyard at Hakkinsack." (NY Lutheran burial records). Five children are found, order of birth uncertain: 1. Andries, born New York per his marriage record, married first Rachel Demarest and second Antie Laroe. 2. Adam, born New York, per marriage record, married Abeltje Slot. 3. Albert, born Hackensack, per marriage record, married Margreta Matthys. 4. Margareta, born Bergen, per marriage record, married first Johannes Lassen and second Richard Kock. 5. Willem, born Hackensack, per marriage record, married Temperence Loverens.

The Mabie Family — Aechtje Jans, the wife of Pieter Casperszen (Mabie), married first, Abraham Williamszen Tietsort on 27 April 1647 (NYDC 1:14). ("Abraham Willemszen, j.m. Van Amsterd, en Aechtje Jans, j.d. Van Norden.") In these records, by Dominie Selyns, the use of "van" before the name, means by consistent usage, the place of birth. Therefore, we know that Aechtje Jans was born in Norden, Netherlands. Aechtje was still living in 1686, per Do. Selyns membership list: "Aecht Jans, wed. v. Pieter van Naerden." (HSYB 1916:28).

Pieter Casperszen and his wife Aechtje Jans had six children baptized in the New York Reformed Dutch Church. 1. Marritien, bp 12 Sep 1652; 2. Jan, bp 4 Oct 1654; 3. Engeltje, bp 6 Sep 1656; 4. Metje, bp 14 Apr 1658; 5. Casper, bp 15 Feb 1660; and 6. Tryntie, bp 17 Dec 1662. Pieter's name is variously spelled in the church records as Pieter Casparszen, Pieter Van Naerden and Pieter Casparszen, Van Naerden meaning his place of birth. ■



— Here's a clipping I thought you might put in *The Archivist*. It reminded me of the *Van Voorhees* 

*Newsletter* that, for some reason, was returned to the sender. When I received the following newsletter, it had a small paragraph saying that I was a "missing cousin," and if anyone knew my whereabouts, they should let the Association know. So, I was not lost, I was just in Florida!

The clipping is from *The Palm Beach Post*, March 23, 1997, by Frank Cerabino, "Can't find pal? Think he died? Try checking in Fla. first" Here are a few excerpts: "Before you assume somebody's dead, check Florida," I told Todd Weiss, a newspaper reporter from PA, who was trying to track down his former seventh-grade teacher.

"A lot of people who are said to be dead are really just in Florida," I told Weiss. "Technically, it's not the same thing."

Weiss called his old school, and was told the teacher, Mr. Hofferman, had died several years before. But Weiss just had a sense that the teacher was really still alive. In desperation, he started calling all the Hoffermans in the Philadelphia phone listings, and finally connected with one who said he had a distant cousin by that name who had retired to Florida, and took down his phone number to pass it on. After filtering through several relatives, the message finally reached Manuel Hifferman, who had retired to Jupiter, FL. He called Weiss.

"As soon as I heard the voice on the phone I knew it was him," Weiss said, when he related the story to Frank Cerabino, the author of the *Palm Beach Post* article.

I told him, Cerabino said, "In the future, make sure you check with us down here before you say somebody's dead. We're loaded with people in the various stages of death." ■

# THE MABIE VIRUS REVISITED

Several readers wrote to inform us of errors in the article, "The Mabie Virus" by Ethel K. Kolenut in the February *Archivist*. Ethel wrote, "Wow, is my face red!" She apologizes and says she checked and double checked her dates, but goofed on the name.

#### Here is Ethel's correction:

Gerrit Blauvelt had eight children with his first wife Saratje Van Schyven. Their seventh child ISAAC, born 24 March, bp 13 Apr 1735 (Tappan #811), married etc.

Should read...

Gerrit Hendrickszen (Blauvelt) and his first wife Marretje Lambertse (Moll) had a son Isaac, bp 27 January 1666 (NYDC 2:81), who married his stepsister Marritie Van Norden. They were raised together etc...

Gerrit Hend. Blauvelt and Marretje Moll had twelve, not thirteen children. If you check the bp of their fourth child Lysbeth, you will note that she is squeezed in. I sent all my documentation to Ralph Blauvelt and it was accepted.

Lysbeth, bp 8 Dec 1652 (NYDC 2:33), is the daughter of Gerrit Hendrickszen Van Harderwyck and Ytie Jans. You can check the Orphanmaster records. HSYB 1900: 118, 119, 124.

**Barrie Mabie** of Scarsdale wrote in reference to his article on the Mabie family in the May 1996 *Archivist*:

• The Archivist, May 1996, p. 8, col. 2, an error - I am sorry about a mistatement regarding the number of children born to Peter Johannes Mabie and Maria Bell, his first wife. This Maria Bell (1738-about 1767) bore only two children to Peter Johannes (a son and a daughter). He married, secondly, on 21 Dec 1769 NY Dutch Church, Sarah Boyd, who bore five additional children to Peter Johannes, for a total of seven children. A date of marriage has not been found for Peter Johannes Mabie's first marriage. However we found at the Johnson Library a couple of years ago, in a volume entitled Names of Persons For Whom Marriage Licenses Were Issued by the Secretary of the Province of New York Previous to 1784, by Secretary of State Gideon Tucker, published in 1860, a listing for Peter Maby and Mary Bell. They were issued a marriage license on 18 Aug 1762. This Peter Johannes Mabie is #269 in the Mabie Compendium, and is my great great great grandfather, who was born in 1735 and died 1823.

• *The Archivist*, May 1996, p. 9, no error, just a comment. There is a reference to a Maria Bell who married Peter Cornelius Mabie #742 in the Mabie Compendium. This is not the same Maria Bell who married Peter Johannes Mabie, my 3Xgreat grandfather. I have not researched that Maria Bell, but it has caused many errors. There may even be a third Maria Bell.

The DAR record book is in error, and the SAR genealogist had a hard time accepting my information

as fact. However, after a two year delay, a several correspondences, they accepted my documentation and reasoning; now I'm a member.

• *The Archivist*, November 1996, p. 3, a comment — Ree Hopper's article, "Did You Know?" mentioned the interchangeability of "I" and "J" which was done up until the late 19th century. This explanation was helpful in understanding the relationship between Johan Johannes Mabie and John I. Mabie. In an indenture that I have, John J. Mabie was referred to as John I. Mabie, Jr. I was glad to have that little mystery solved. ■

# A Courter Family of Bergen County, NJ

by Judith Courter Ullman 404 Red River Trail #1017 Irving, TX 75063

Arye Courter and Lena Van Voorhees were married at Pompton Plains Reformed Church in 1746. A daughter Maria was baptized 28 Dec 1746 at Pompton Plains.

They probably had a son William, born about 1751 and possibly another son, John, who married Caty -?-.

In the year 1753, Arie and Lena Coerte were sponsors at the baptism of Johannes A. Rutan, son of Abraham Rutan and Sarah Van Gelder. In that year Arie leased land in the Ramapo Tract. We find him in tax records of Franklin off and on until 1794 when he probably died. He was exempt from taxes 1777 and 1778. His next door tax neighbors are usually John and William Courter.

William Courter was born probably 1751. He was in the Bergen County Militia for the Revolutionary War. He married Trintie Winters about 1775. He first appears on tax lists in Franklin Township 1778 and continues in Franklin and Pompton Townships until 1822 at various times living next to his sons, William, Aaron, or John. In 1826 after many land transactions and mortgages, Jacob Van Wagoner files fieri facias against William Courter, Abraham Van Voorhees and Isaac Van Voorhees. Jacob Van Wagoner purchases property and we next find William without his wife in 1830 living with Henry and Hester Stur. In 1838 the state of New Jersey awards \$60 a year for a Revolutionary War pension. He was living with Hester and Henry Stur in 1840 and probably died 1843.

William and Trintie probably had the following children:

- Aaron Courter, b. 23 Dec 1776 at Mochopin; m. Sophia Ackerman;
   William W. Courter, bp. 24 Jan 1779 Totowa Ref Ch; m. Antje Ackerman;
- John W. Courter, b. about 1780;

- Ellen Lettice Courter, b. 1 Dec 1791; m. Henry Winter.

The descendants of William W. Courter, Hester S. Courter, and Ellen Lettice Courter have been recorded at other times and places.

Aaron Courter married Sophia Ackerman; their lives have not been recorded. They probably married about 1800 and probably had the following children:

- Abraham Courter, b. 1801; d. 1891; m. Anna Marinus;
- William A. Courter, b. 1804; d. 1890; m. Eliza Brown;
- James Courter, b. 1807; d,. 1899; m. Hannah Forshee;
- unknown, b. about 1810;
- Catherine Courter, b. about 1813;
- · Benjamin Courter, b. about 1815;
- Isaac Courter, b. about 1818; d. 1898; m. Sarah (Sally) Storms and Margaret Quackenbush;
- Christina Courter, b. about 1820.

Aaron Courter was involved in many land transactions, mostly in Mochopin (Macopin) and Charlottesburg Plantation. These sales involved his father, William, and Anne and Albert Terhune.

Both Aaron Courter and Sophia Ackerman d. 1860 and were buried at the Hopper Cemetery at "Small Lots," now part of Glen Rock, Bergen County, NJ. There are no records of his purchasing his homestead at Small Lots or the sale of this property after his death.

The sources used are various death certificates, land transactions, tax records, cemetery records, census records, church records, mortgage records, Revolutionary War Mss., Chancery Court records, and information from Paul Courter, Lucy DeBaun, Emily Clawson, John Jeremiah Everson, Mary Everson, Julia Everson, Steve Winter, Pat Wardell, and Phillip O'Leary.

#### Abstracted by Philip O'Leary, III

Geographical Note from the *Archivist* Editor: As you read these abstracts, keep in mind that the original area of Bergen Country was quite large. Its area at one time included today's Passaic County (established 7 Feb 1837) and Hudson County (est. 22 Feb 1840). In addition, there were some adjustments to boundaries even after 1840. For instance, in the 1850 Federal Census, let's say your family was in *Harrison Township in Hudson County*. In the 1860 Federal Census, without even making a physical move out of the old homestead, the family might be listed in *Union Township in Bergen County* (in 1852 part of Harrison Township, Hudson County, was added to Bergen County as Union Township). Even some southern parts of Orange and Rockland Counties in New York State were at one time considered by some to be in New Jersey.

The earliest published American road maps (including New Jersey) were in Christopher Colles' <u>A</u> <u>Survey of the Roads of the United States of America</u>, (N.Y., 1789). The next, devoted in large measure to New Jersey, was J. J. Moore and T. W. Jones' <u>The</u> <u>Traveller's Directory: or, a Pocket Companion</u>,

Shewing the Course of the Main Road from Philadelphia to New York... (Phila., 1802).

By mid-century there were many published road maps. In the 1880s, with the tremendous interest in bicycle touring, folding pocket maps showing state and local roads became very popular. The League of American Wheelmen published scores of regional road maps, as did commercial mapmakers such as Mueller. The latter firm published a great New Jersey road map, which it updated regularly for many years.

The state of New Jersey became greatly interested in improved public roads in the 1870s. By the early 1890s the Commissioner of Public Roads began to issue annual reports, and many of these included maps of New Jersey roads. The New Jersey volume of Adelaide Hasse's <u>Index of Economic Material in Documents of the United States</u> (Wash., 1914) provides a wealth of government literature on New Jersey roads, roadmaking, and maps before 1904. John Snyder's <u>The Mapping of New Jersey</u> (New Brunswick, 1973) contains quite a bit on nineteenth century New Jersey road maps. ■





# Germans to America

According to the May 1997 issue of The Newsletter of the Immigrant Genealogical Society, the March 1997 issue of the Palatines to America's The Palatine Immigrant contains the translation of an article about Glazier and Filby's Germans to America that appeared previously in the German publication Genealogie last fall. The author compared the German to America indexes to the original passenger lists. He gives specific examples of ship lists on which some family members were omitted and classified as another nationality. Returning Americans were considered German immigrants, persons who died enroute were listed as arriving immigrants, many places of origin were wrongly reported as unidentified. The greatest error was trying to give numerical codes to thousands of villages and using the same number for different villages in different volumes. Anyone finding clues in Germans to America should check the original passenger list. The information you want is very possibly there. - Frank Poole (anyone wishing to read the article should contact Frank).

# International Reply Coupons in Germany

New regulations of the German Post Office allow only one International Reply Coupon (IRC) to be used for any letter or package. One IRC provides 3 DM of postage for mail to the USA. That covers one sheet of paper and the envelope. If your correspondents are sending enclosures, they must pay for the extra postage.

WANAMAKER, STURR (STORR), MAYSINGER (MESSINGER), were German Palatines who took part in the mass migration from Rotterdam to England in 1709. In 1710 they were settled by the British at West Camp (near Newburgh, NY) to prepare naval stores. The colony failed and was disbanded. Several families moved to the Ramapo Tract 1713-1714, leasing or purchasing land. Some are buried in the Moffatt Road Cemetery in Mahwah.

THEISEN (TICE) were Dutch. WINTERS came from River Vale, NJ to Mahwah.

I suggest you consult <u>Palatine Families of New</u> <u>York</u> and <u>More Palatine Families</u>, by Henry Z. Jones, Jr. for families of the first settlers. Also <u>From Pioneer</u> <u>Settlement to Suburb</u>, a History of Mahwah by Henry Bischoff and Mitchell Kahn.

From the book, <u>Shuah Strait Mann 1829-1918</u>, by Pauline Bachman Mann, p. 12: "Quoted from <u>20th</u> <u>Century History of Delaware County Ohio and</u> <u>Representative Citizens</u>: 'Shuah Sr.'s wife was the daughter of Charles Oldham, born and raised in Manchester, England. He came to America in the Revolutionary War and joined the American Army. His brother, Major Oldham, fell in battle. Charles was a Captain in the war. He settled in New Jersey, served as a constable 9 years, Justice of the Peace 3; Sheriff, 3' To this Lucy Ann Swickard of Colony, Kansas added: 'He was twice married and had many descendants.'"

Our line descends from Charles Oldham's daughter, Nancy Oldham Mann through her #1 daughter Elizabeth Mann, b. 27 Oct 1809, m. John Mills in Sussex County NJ 28 March 1829, d. 8 Jan 1886 in Linn Co., PA.

His nephew James H. Young (1820-1864) made a will in 1864; probated Sep 19, 1864. The estate was not settled until 1891 after the death of his wife Lavinia Christopher.

There is no other James in this branch of the family. James Young, Esq. was my gr-gr-grandfather.

• from William Walling, Bordentown, NJ — Re: article on **Fortitude Lodge**, **Ramsey** in May issue of *The Archivist*.

On April 28,1988 Hawthorne Lodge # 212 F&AM merged with Fortitude Lodge # 200 to form Hawthorne-Fortitude Lodge #200. This, to the best of my knowledge, continues to meet at 24 N. Franklin Tpke, Ramsey.

♦ from Robert Hubbard, Hillsdale, NJ — Re: Van Bussen, Post families.

I'm writing to let you know of two of my ancestors who could not be traced further in two genealogies, and who, after doing my family tree, can now be traced back further.

The first was **MARGARET VAN BUSSEN**, who married Jacob Haring in 1808 at Hackensack. He was the son of John and Elizabeth (Van Emburgh) Haring, born in 1780. Margaret's line is listed as nothing further in the Haring Genealogy. Her parents were John Van Bussen and Antje Cadmus and she was born 28 Nov 1790 at Acquackanonk; bp. 17 Jan 1791 Acquackanonk Ref Ch; d. 23 Nov 1858 at Slotterdam, NJ and was probably buried at Dundee Cemetery. Her death is recorded in an old book at Hackensack Library that recorded Bergen County deaths. She is also found in the records of the Second Reformed Church of Paterson as leaving the church in 1858 due to death.

The second ancestor was JENNEKE/JANE POST who was listed in the Van Blarcom Genealogy as nothing further. She was born 14 August 1785 at Acquackanonk and bp. there 25 Sep 1785, daughter of Henrick Frans and Jannetje (Van Houten) Post. She married 13 Sep 1807 at Acquackanonk, Hendrick Van Blarcom, widower of Dirckje Ackerman. Jane Post Van Blarcom died 27/28 Dec 1872 at Rutherford, NJ, supposedly aged 86.4.15. The reason she was not traced further is that her age was probably really 87.4.15. The age fits exactly to Jenneke Post born 14 August 1785.

### NATIONAL GENEALOGICAL SOCIETY CONFERENCE 1997 a review by Donna Ristenbatt

The name "Valley Forge" will usually evoke thoughts of General George Washington crossing the Delaware, or the long difficult winter for the Continental Army in 1776/77. This year, however, mentioning Valley Forge to a genealogist evoked rather different thoughts - thoughts of a great genealogy conference held at the Valley Forge Convention Center May 7-10 by the National Genealogical Society and hosted by the Genealogical Society of Pennsylvania.

I was privileged to attend the NGS Conference this spring, with a brief hiatus on Friday evening and Saturday morning due to some previous family engagements. I was determined to go back Saturday afternoon however to attend the session on "German and Swiss Immigration Through the Centuries" led by Annette K. Burgert, Maralyn Wellanauer, and the well known Henry(Hank) Z. Jones, a two hour session, and well worth the trip back to Valley Forge. (I am fortunate to only live an hour and fifteen minutes away from this great historic spot!) Additionally on Saturday, I was also privileged to meet the daughter of Lucille Ball, Lucie Arnaz. She was there in person promoting her new CD-Rom Software "How to Save Your Family History - A 10 Step Guide."

From "Day One," the Conference was well organized and very well attended. There were numerous courses being offered every hour; it was difficult to choose, and one could start early in the morning and go well into the evening. The emphasis at this Conference tended to be on Pennsylvania records, German/Swiss immigrants, UK + Ireland records and computer programs and software. There were other courses as well that touched on New Jersey, New York, Scotland and other localities and subjects. Most of the lecturers were quite good, and those of particular note (from courses that I attended) were Hank Jones, Sherry Irvine and Jonathan R. Stayer.

A special feature of the Conference was the selling of tapes for most of the courses, so if you were attending one course and wanted to hear another one being presented at the same time, you could purchase a tape of that course.

A well visited place was Exhibition Hall where many societies and book companies such as Heritage Books Inc., Genealogical Publishing Co. of Baltimore, and many more, had booths.

The NGS also gave every conference attendee a complete Program Syllabus of all the courses that were presented, so even if you did not attend all of the courses (which would have been impossible!), you could still have an outline of what was taught in these courses.

A few negatives included the long walk between courses for many people and the lack of good bus service from the motels. There was supposed to be a bus shuttle from the various motels, but it was very unreliable. All in all, though, the NGS Conference 1997 was well worth attending and I am very glad I went!

### GENEALOGICAL ABSTRACTS OF REVOLUTIONARY WAR PENSIONS OF RESIDENTS OF BERGEN COUNTY, NJ

### Abstracted by Philip O'Leary, III

Note: An asterisk (\*) or (\*Abstracter's note) indicates a note or interpolation by the abstracter of these records.

### Benjamin and Mary(Brower) Romain

Benjamin Romain, Sgt., NJ Militia, Revolutionary War Pension No. W18839.

New York City, NY Co. Common Pleas Court, 27 May 1834, Benjamin Romain, age 71, a resident of NYC; b. 24 Sep 1762, Poughkeepsie, Dutchess Co., NY; at time of enlistment, age 15yrs 3mo, lived at Hackensack, Bergen Co., NJ; lived at Schraalenburgh with my mother after my father died. Served in my brother's, Captn. Elias Romain, company, under Sgt. Marius. "I was under the command of Col. Dey, when the whole county of Bergen was summoned to dislodge the enemy from Ft.Lee. The attack was made at day break and the enemy fled and never again attempted to form a station at that place." While a prisoner at Sugar House prison in NYC, I was pierced in the arm and Elias Day was pierced in the thigh from a bayonet, by Captn. William Arden, Chief of the Guards, for harassing Samuel Cole, the Tory, from Closter. Elias Day, myself, Cornelius and Benjamin Westervelt, and Daniel Vervalen, who were also wounded, were in a prisoner exchange.

Children of Benjamin Romain (d. 21 Jan 1844), m. 12 Dec 1784, NYCDC, Mary Brower(d.14 May 1844 NYC):

1) Samuel B; an attorney of NYC as of 05 Jan 1847.

2) Ann, w/o Charles Nichol, Counsel of the USA at Amsterdam.

3) Hannah, w/o Henry M. Western.

Others mentioned in pension: Rev. John Demerest, James Hopson. All testifying as fellow soldiers in the Revolution: Daniel Vervalen, of NYC, 10 Jul 1841; Samuel Vervalen, of Rockland Co., NY, 05 Mar 1834; Elias Day, Sylvester Marius, of NYC, 27 May 1834; James Riker and John A. Haring, both of NYC, 28 May 1834; Peter Vanorden, of Rockland Co., NY, 27 Oct 1836; Philip Demerest, of Sodus, Wayne Co., NY, 03 Apr 1833; Samuel Helm, of Closter, Bergen Co., NJ, 03 Apr 1833.

### George G. Ryerson

George G.Ryerson, Pvt., Lieut., NJ Militia, Revolutionary War Pension No. S1098.

Bergen Co., NJ Common Pleas Court, 31 Oct 1832, George G. Ryerson, age 79, a resident of Pompton Twp., Bergen Co., NJ; b. 25 Sep 1753, in the part of Saddle River Twp., Bergen Co., NJ; now called Pompton Twp. Father, George Ryerson, now deceased. Volunteered at Pompton Twp. 1776. Shot through right leg from British musket ball, British Army burned house of Adam Boyd in Hackensack. Elected Lieut. in place of Lieut. Gilles Mead, of my company, who joined the Continental Troops.

Others mentioned in pension: Rev. Issac Demmand, pastor of the Pompton RDC, John G. Ryerson, age 72, of Pompton as of 03 Mar 1834 and brother of George G. Ryerson. ## **Bergen County Church Records**

Compiled by Maria Pratt Hopper (Ree), with additions by Ethel K. Kolenut and Pat Wardell

Most researchers in Bergen County Genealogy are familiar with the records of the oldest local Dutch Reformed Churches of Hackensack, Schraalenburgh, Paramus, Acquackanonck, Tappan and Clarkstown, which have been published and are in many libraries throughout the country. But did you know that each one of those churches has records that go beyond the published records? These "Book Twos" as we refer to them, are not as widely circulated, but are available locally. They are usually in typewritten or purple ditto versions. Many were copied for the Association of Blauvelt Descendants, or by Ackerman and Goff. Thanks to Ethel Konight Kolenut, copies of most are in the Genealogical Society of Bergen County's library. The exception being The Church Tablet, which can be found at Bergen Co. Historical Society Library (Johnson Public Library in Hackensack), the Passaic Co. Historical Society (Paterson), or the NYGB Library in NYC (which has a complete index to all issues). The Passaic Co. Historical Society also has a hand written, abstracted copy of church records (arranged alphabetically), copied by Mattie Bowman of many of the local churches including Totowa, which goes beyond the previously published works.





3. Use common, clear abbreviations. If you're not sure of an abbreviation, use the complete word or term to avoid misunder-standing.

 — Re: article on Bergen County Church Records in the August issue of *The Archivist*.

You wrote of the different church records in the last newsletter. Could you request the sources where people find the records of these churches be added to the name of the church in the newsletter? I especially am totally confused when someone writes about the Ackuackenock Church or then they say the Totowa Church or then they call it the Paterson or Passaic Church. I keep thinking I am missing some church records.

One source I use all the time is the LDS film #1019522 Records of Marriages and a few Baptisms by Rev. Joseph Wilson, Nov 5, 1822 to Apr 26, 1877. These are the records of the Fairfield Reformed Church. I had a hard time finding them. Another church that was not mentioned was the Reformed Church in Bloomfield, LDS #0946019. It has Dutch families from both Pompton and Caldwell and Passaic County.

Editor's Note: We think Judith's idea of referencing locations of the records would be a helpful addition for an update to this church article. We need your help, readers: please write and tell us where you found these records (in what repositories are they located?) and any details (reel numbers, etc.) that would be helping finding aids.

♦ from Dave Henry, via e-mail — Recently, a Pension Records list was printed, and contained the name of my 5th great grandfather, Thomas Carman, with no information on him. From my own files, he served in Captain Alexander Mitchells Company, of the New Jersey line. He was a resident of Bloomingdale, NJ at a place called "Carmantown," about two miles north of Bloomingdale. He was the first white settler of the region, and his house, built about 1782 and rebuilt in 1820, still stands as the oldest house in Bloomingdale.

He married 1) Hannah Vreeland (d/o Abraham Vreeland and Effie Van Zile) and he married 2) in 1814, Nancy Sisco (Francisco), who was a widow of Barney Francisco of Pecquanonk, Morris County. Nancy's maiden name was BRUEN. Thomas Carman died in 1849, and Nancy remained his widow, dying in 1857 in "Carmantown," Passaic County. It is through his son Abraham Carman that I am descended (his wife being Sophronia or Francis) and through their son Peter Carman, who married Martha Tallman, I am descended from the Blauvelts and Harings, etc.

Peter and Martha (Tallman) Carman had a daughter Mary "Mame" Carman, who married William Edward Henion of Mahwah (Hohokus) the last born son of Martin Henion/Hennion and Leah Garrison (the widow Westervelt) of Darlington. William died at a young age, and his daughter Lillian Carman Henion married Frederick George Henry of Hackensack.

Thier son, David, was my grandfather. When Martin Hennion died in 1877, his will gave to his two sons David and William (he and his wife Leah had a combined total of 24 children), the homestead farm in Darlington, and directed that the mother Leah be taken care of during the rest of her life, with the rest of the 350 acres to be divided amongst all of the children, equally. The other family members contested the Will, apparently won, and the entire property sold for a mere \$5,000. as I understand it. Had it not been for his sons David and William. Martin would have died alot sooner, for a newspaper article reported that Martin was at work in his Saw Mill, when he had caught himself in the Saw mechanism and was almost cut to pieces when his son pulled him out of the entrapment and saved him.

Peter Carman (1833-1923) owned the old Mount Prospect Hotel on Franklin Turnpike [in Ramsey], which I understand now is the site of the Ferncroft Apartments. Peter operated a Tavern in Hohokus for many years, and travelled back and forth over the Paterson Hamburg Turnpike, owning Hotels and Taverns from Hohokus to Sussex, NJ. He was "compelled to leave Hohokus" for operating a Tavern too close to a Church, and for "failure to obtain a Tavern license." This was in the early 1870's, but Peter returned and purchased the Mount Prospect Hotel (Ramseys), and did a very lively, and somewhat famous business for miles around. His famous "Balls" and "parties" were noted on a constant basis in the Bergen County papers. He also held "Court" at his hotel, as numerous Court cases were to be heard there. He was known as "Judge Carman," although he was never appointed to any Jurist position.

His children married into the area families, such as Terwilliger, Poole, Henion, Crouter and others.

Martha (Tallman) Carman (Mrs. Peter Carman) was the daughter of Garret Jacob Tallman and Sarah Davenport, who removed from Bergen County to Oak Ridge about 1834. Sarah Davenport was the daughter of Peter Davenport and Maria Cole. ■

## Tracking Down Those Irish Immigrants by Louisa Lavelle

I finally hit paydirt and found the place in Ireland where the first Lavelle (and another ancestor) came from.

Someone in the New York Public Library (NYPL) discovered that the records of the Emigrant Savings Bank contained a goldmine of genealogical information. So in mid-September I made a trip into New York to check this source.

The bad news is that the surname index is alphabetical by the first letter of the last name only, and you have to go to the Manuscripts Room at the NYPL to see it. The good news is that bank clerks from 1850-1880 had much better handwriting than census takers, so it's not bad reading the microfilm. The immigrants applying gave their names, addresses, date and place (town, county and country) of birth, spouse's maiden names, sometimes parents names in Ireland (especially if not married), the date of arrival and ship's name.

The index gives the name and a number, which is the Test Book # where this information can be found.

While there, I stopped in the Local History and Genealogy Room — where I got my first information years ago, and got the Internet address for library holdings since 1971:

I hope this may help someone else frustrated with those famine Irish.  $\blacksquare$

John A. Blauvelt, NY; NJ Militia, Revolutionary War Pension No. S956.

NYC Marine Court, 09 Jul 1833, John A. Blauvelt, age 71, a resident of NYC, b. 14 Aug 1760 at Tappan, NY. Living at Closter, Bergen Co., NJ when enlisted in service, then Harrington, Bergen Co., NJ after the War, then in May 1832, moved to NYC. I also served as a substitude for \_? Banta or \_? Demarest. In May 1835, asked for pension payments to be transferred to Harrington, Bergen Co., NJ. I know Benjamin Romain and Henry Van Houten, who can testify as to my War service. Others mentioned in pension: Jacob Westervelt, High Sheriff of NYC. All testifing as fellow soldiers in the Revolution, Matthias Riker, James Riker and Sylvester Marius, all of NYC as of Jul 1833.

#### **James Benson**

James Benson, Pvt; PA Continental Line, Revolutionary War Pension No. R778.

Bath Co., KY Common Pleas Court, 27 Jul 1831, James Benson, age 87, enlisted for 1 year at Bergen, Bergen Co., NJ with the PA Continental Line on 10 Sep 1776, taken prisoner in Nov 1776, after exchange of prisoners, I was taken to the Philadelphia hospital and discharged in 1778. Wife Elizabeth, age 74, has been blind for 9 years. I have lived in the mountain frontiers of this state for the last 20 years, except for a short time in the Poor House of this county.

### John G. and Ann (Blanch) Blauvelt

John G. Blauvelt, Pvt; NY; NJ Militia, Revolutionary War Pension No. W20728.

Rockland Co., NY Common Pleas Court, 27 Nov 1832, John G. Blauvelt, age 73, a resident of Orange, Rockland Co., NY; b. 15 Nov 1759 Orange, NY, record at Tappan RDC. At the Battle of White Plains, one of my neighbors, Abraham Onderdonck, was killed when a British cannon ball blew his head off. I also volunteered in the Bergen Co., NJ Militia under Captn's Thomas Blanch and Abraham Haring. I know the following men who can testify as to my War service, Cornelius, Richard and Garret Blauvelt, John C. and Abraham Smith, \_\_\_? Sickles. Rockland Co., NY Common Pleas Court, 13 May 1843, Ann Blauvelt, age 78, a resident of Orange, Rockland Co., NY, widow of John G. Blauvelt, who d. 15 Mar 1842. Married Nov 1782, had one child, Elizabeth, b. 07 Apr 1784.

Others mentioned in pension: Elizabeth Blauvelt, Ann Eliza Dederer, both of Orange, NY were present at funeral of John G. Blauvelt. John Blanch, age 72 of Orange, NY and brother of Ann Blanch Blauvelt, as of 13 May 1843. All testifing as fellow soldiers in the Revolution, John G. Bogert, age 78, John Tallman, age 82, both of Rockland Co., NY as of 13 Dec 1833, Abraham Haring, age 77, a resident of Ramapo, Rockland Co., NY as of 29 Nov 1832, recollects a Henry Cooper was wounded and taken prisoner to NY where a surgeon removed his leg, he later recuperated and was sent home.

John Mc Gannah and Robert Fowler can testify as to my war service. Others mentioned in pension: Rev. John Boyd and Jacob Carpenter. Maria Tanner/Tannery, age 73, a resident of Orange Co., NY, testifies on 05 Dec 1832, that she was born and brought up in Bergen Co., NJ and her father's house and Crynes Bertolf's father's house were in sight of each other, her husband, Peter Tanner/Tannery, and brothers, Aaron and John Jenkins, were in the same company as Crynes Bertolf during the Rev. War. Testifing as a fellow soldier in the Revolution, John

Christie,age 84, a resident of Franklin Twp;Bergen Co;NJ.

### Peter Beam

I was put out as an apprentice, by my father, when I was 14 or 15 years old to Morris Co., NJ. I have lived in Bergen Co; Morris Co; Sussex Co; Warren Co; and back to Morris Co; NJ. I know the following men who can testify as to my war service, Col. Samuel Beach, Chilton Beach, Matthias (\*Killand?), William Jackson, and the Rev. Barnabas King, pastor of the Presbyterian church at Rockaway. Others mentioned in pension: All testifing as fellow soldiers in the Revolution, on 21 Feb 1834, and all of Pompton, Bergen Co., NJ, Anthony Beam, Conrad Lines, John Beam.
